

# NOTICE OF DIRECTORY INFORMATION AND OPT-OUT FORM

#### **NOTICE OF DIRECTORY INFORMATION**

In accordance with Federal Educational Rights and Privacy Act of 1974 (FERPA), as amended, a student's education records are maintained as confidential by Kenyon College and, except for a limited number of special circumstances listed in that law, will not be released to a third party without the student's prior written consent. The law, however, does allow Kenyon College to release student "directory information" without obtaining the prior consent of the student. At Kenyon, we consider "directory information" to be those items listed below in this form.

Kenyon College defines "directory information" as the following categories of student information: a student's name; electronic mail address; photograph, majors; status for the semester (full or part-time); class year; dates of attendance; participation in officially recognized activities and sports, the most recent educational agency or institution attended and degrees, honors, and awards received.

If you do not want Kenyon College to release your directory information without your prior consent, you may choose to "opt-out" of this FERPA exception by signing the FERPA DIRECTORY INFORMATION OPT OUT FORM provided below. This form must be received in the Registrar's Office by the tenth day of the Fall semester in order for it to be applicable to that academic year.

Students should keep in mind that "opting-out" of the release of certain directory information will limit Kenyon College's ability to confirm things like your record of attendance with prospective employers, graduate schools or student loan officials. Once you have designated a confidential classification, it will not be removed until you submit a signed authorization requesting that it be removed.
